

SISTER REEF PROJECT SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE, PAYMENT, OR DONATION NECESSARY TO ENTER, WIN, OR CLAIM A PRIZE. A PURCHASE, PAYMENT, OR DONATION WILL NOT INCREASE YOUR CHANCES OF WINNING.

The Sister Reef Project Sweepstakes (“Sweepstakes”) is sponsored by The Belize Tourism Board, PO Box 235, #106 South Street, Belize City, Belize (“Sponsor”).

1. **SWEEPSTAKES PERIOD:** The Sweepstakes begins on March 8, 2018 at 12:00 PM Eastern Time (“ET”) and ends on March 29, 2018 at 11:59:59 PM ET (“Sweepstakes Period”). The Administrator’s computer is the Sweepstakes official clock.
2. **ELIGIBILITY:** This Sweepstakes is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. The following individuals are not eligible to participate: (i) any person who was employed at any time during the Sweepstakes Period by Sponsor, or any of their affiliate companies, subsidiaries, or advertising, marketing or promotion agencies, including employees of independent third-party Sweepstakes administrator (“Administrator”), and its respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, “Sweepstakes Entities”) and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the “steps” of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. Void in where prohibited or restricted by law.

Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions and interpretations, which are final and binding in all matters related to the Sweepstakes.

3. **HOW TO ENTER THE SWEEPSTAKES:** During the Sweepstakes Period, an eligible entrant must visit SisterReefProject.com (“Website”) and register by entering the information requested on the registration form, which may include, without limitation, email address, password (entrant must create a password to register, which is free to do), complete first and last name (initials not permitted), street address (PO boxes not permitted), city, state, ZIP code, telephone number, date of birth, and affirmation that he/she has read and agrees to be bound by these Official Rules. Following registration, an entrant may earn credits (each, a “Credit”) to use to enter the sweepstakes. There are two (2) methods for entrants to earn Credits:
 - i. **Make a Donation:** An entrant may follow the instructions at the Website to use his/her valid credit card to make a donation to World Wildlife Fund. An entrant will receive one (1) Credit, awarded to his/her account at the Website, for every \$5.00 donated, up to a maximum of one thousand (1,000) Credits for a total of \$5,000 donated. The following increments of donations are allowed: \$5 (1 Credit), \$10 (2 Credits), \$25 (5 Credits), \$50 (10 Credits), \$100 (20 Credits), \$250 (50 Credits), \$500 (100 Credits), \$1,000 (200 Credits), \$2,500 (500 Credits) and \$5,000 (1,000 Credits). Regardless of the amount donated, an entrant is limited to making ten (10) separate donations. Note that an entrant may donate more than \$5,000.00 but can only receive the maximum 1,000 Credits. “Sister Reef Project” will appear on an entrant’s credit card statement.

- ii. Receive Credits without making a Donation: To receive a Credit without making a donation, an entrant may visit SisterReefProject.com/AMOE and complete the request form, which may include, without limitation, email address, complete first and last name (initials not permitted), street address (PO boxes not permitted), city, state, ZIP code, telephone number, date of birth, and affirmation that he/she has read and agrees to be bound by these Official Rules to receive one (1) Credit awarded to his/her account at the Website. An entrant will receive one (1) Credit each time he/she completes the free online request form (up to the limit stated below). Note: an entrant must be registered at the Website to receive a Credit via this method.

Regardless of the method used to receive Credits, an entrant may receive no more than one thousand (1,000) total Credits during the Sweepstakes Period.

Using Credits to Receive Sweepstakes Entries: The Sweepstakes will include forty-one (41) separate entry pools (each an “Entry Pool”). After receiving a Credit or Credits, during the Sweepstakes Period, an entrant may follow the instructions at the Website to apply his/her Credit or Credits to receive an entry or entries into an Entry Pool. An entrant will receive one (1) Sweepstakes entry into the Entry Pool selected for every one (1) Credit entered into the Entry Pool selected. At the outset of the Sweepstakes, the prize available in each Entry Pool will be hidden to the entrant. The prize for an Entry Pool will be revealed to an entrant when the entrant uses a Credit or Credits to receive an entry or entries into that Entry Pool (note: the Prizes for all Entry Pools will be revealed to an entrant when the entrant has received a total of twenty (20) Credits during the Sweepstakes Period).

IMPORTANT: If using a mobile device to participate in the Sweepstakes, data rates may apply. Not all mobile telephone providers carry the service necessary to participate in this Sweepstakes. Entrants should consult their wireless providers’ pricing plans.

- 4. **RANDOM DRAWINGS:** On or about March 30, 2018, the Administrator will randomly select one (1) potential winner from all eligible entries received into each of the forty-one (41) separate Entry Pools during the Sweepstakes Period for a total of forty-one (41) potential winners. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

Any portion of a Prize not accepted by a winner will be forfeited. Federal, state, and local taxes on the Prize and any expenses relating to the acceptance of and use of a Prize not specified herein are the responsibility of a winner. Sponsor will issue an IRS Form 1099-MISC for each winner of a Prize valued at \$600 or above. Each Prize will only be awarded to a verified winner.

LIMITATION OF LIABILITY:** By participating in this Sweepstakes, entrants agree that the Sweepstakes Entities and each of their respective affiliates, subsidiaries, representatives, consultants, contractors, legal counsel, advertising, public relations, promotional, fulfillment and marketing agencies, website providers and each their respective officers, directors, stockholders, employees, representatives, designees and agents ("Released Parties") are not responsible for: (i) lost, late, incomplete, stolen, misdirected, postage due or undeliverable e-mail/text notifications or postal mail; (ii) any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections, or availability; (iii) garbled, corrupt or jumbled transmissions, service provider/network accessibility, availability or traffic congestion; (iv) any technical, mechanical, printing or typographical or other error; (v) the incorrect or inaccurate capture of registration information or the failure to capture, or loss of, any such information; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Sweepstakes; (vii) any injury or damage, whether personal or property, to entrants or to any person's computer related to or resulting from participating in the Sweepstakes and/or accepting a prize; or (viii) entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules. Further, the Sweepstakes Entities are not responsible for any unanswered or undeliverable winner notifications.

If, for any reason, the Sweepstakes is not capable of running as planned, Sponsor reserves the right, at its sole and absolute discretion, to cancel, terminate, modify or suspend the Sweepstakes and/or proceed with the Sweepstakes, including the selection of a winner in a manner it deems fair and reasonable, including the selection of a winner from among eligible entries received prior to such cancellation, termination, modification or suspension.

DISPUTES: THIS SWEEPSTAKES IS GOVERNED BY, AND WILL BE CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF MICHIGAN, AND THE FORUM AND VENUE FOR ANY DISPUTE SHALL BE IN THE OAKLAND COUNTY, MICHIGAN. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JAMS IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("JAMS RULES"). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MICHIGAN. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN OAKLAND COUNTY, MICHIGAN. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
